Report from Student Representative - Troy Kennedy reported on events and happenings in the Wellsboro Area High School. The National Honor Society raised \$2,000 for Relay for Life. NFA is going to Penn State for state-wide competition. Junior Class is going to the movies as a result of winning Class Competition (paid for by Student Council).

Report from Superintendent — Superintendent Morral presented to David Krick, High School Principal, on behalf of the District, a bronze plaque recognizing Wellsboro Area High School as one of the Best High Schools in America (reviewing 31,242 US Public High Schools and 169 High Schools from PA. This was reported by US News and World Report. Student to teacher ratio, college readiness, reading proficiency and math proficiency were all factored in with this report. Superintendent Morral then addressed to the Board the proposition to implement a 1:1 student to device initiative at our High School. He advised that the District is delaying this for the coming school year for the following reasons: several policies need to be adopted; all in-service days for the coming school year are filled with professional

development activities; lack of infrastructure; we need to implement all aspects of Learning-Focused while ollaboratively developing SLO's that are thorough and comprehensive for each curricular area; uperintendent Morral then introduced Dr. Benjamin Largey and his intern, Danielle Gentile, who gave a report to the Board on their research project: Planning for Positive Child Adjustment and Academic Success after Divorce: A Research-Based Solution Focused Training. Mr. Krick addressed the Board concerning PA School Breakfast, Challenge, PA School Performance Profile, sport, and music.

Report from Business Manager – Business Manager Marcia Newcomb reported to the Board that the central office has been busy finalizing the 2014-15 General Fund Budget. We are preparing for our End of the Year Child Accounting in addition to everything else that has to be done.

## Report from Administrators -

Mr. Adams reported that the Charlotte Lappla Kindergarten registration. He thanked the teachers and secretary for a job well done. He also thanked retiring teacher, Bonnie Stanley, for her years of service. The elementary schools participated in dress for charity for the Armed Forces.

Mr. Hewitt reported that 35 students signed up for summer tutoring. A Parent Meeting for Title 1 Parents will be held in the future as a result of a survey taken.

Mr. Kreger presented to the Board spreadsheets pertaining to Wellsboro High School Overall Discipline Outcome Comparison for 2012-13 vs. 2013-14. He also spoke on the 2013-14 Van Usage and the savings.
