RESOLUTION	

A RESOLUTION OF THE WELLSBORO AREA SCHOOL DISTRICT OF TIOGA COUNTY AND LYCOMING COUNTY, PENNSYLVANIA, DIRECTING THE ADMINISTRATION TO PROVIDE THE BOARD OF SCHOOL DIRECTORS WITH INFORMATION AND TO PERFORM IMPACT STUDIES IN ACCORDANCE WITH THE PROVISIONS CONTAINED IN THIS RESOLUTION.

WHEREAS, the Board of School Directors has requested that the Administration look into the potential for closing one of the School District's four (4) school buildings and/or the Administration Building; and

**WHEREAS**, the District would like to look into the feasibility of closing a building while maintaining the necessary programming, staffing, curriculum, and facilities; and

WHEREAS, prior to proceeding with any school closure pursuant to §7-780 of the School Code of 1949, as amended and supplemented, the Administration needs to provide the Board of School Directors with information necessary to make informed decisions; and

**WHEREAS**, the Board of School Directors desires to reduce its directives in writing in accordance with this Resolution.

# NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

The foregoing recitals are incorporated herein by reference.

If in the event it is determined that a building needs to be closed, the District shall solicit the following information:

## 1. BOND ANALYSIS

Information regarding certain Bonds of the School District:

- a. If the School District closes Charlotte Lappla Elementary, what consequence will this have on the current reimbursement from PDE with respect to the Series 2015, 2016A, and Series 2016AA Bonds?
- b. If the School District closes Don Gill Elementary, what consequence will this have on the reimbursement from PDE with respect to the Series 2015, 2016A, and Series 2016AA Bonds?
- c. If the School District closes Rock L. Butler Middle School, what consequence will this have on the reimbursement from PDE with respect to the Series 2015, 2016A, and Series 2016AA Bonds?
- d. If the School District closes the Administration Building what consequence will this have on the reimbursement from PDE with respect to the Series 2015, 2016A, and Series 2016AA Bonds?

# 2. PDE REIMBURSEMENT

- a. Will PDE do pro-rata reimbursement?
- b. Should the School District ask PDE for guidance on the reimbursement impacts prior to a decision regarding a consolidation of any of the District schools?

# 3. FACILITY MASTER PLAN

Present information regarding the potential closure of a school building. In doing this analysis, the District's consultant should consider the following criteria:

## Criteria

- a. Building Requirements
  - Special Education needs
  - Building Codes
  - ADA Compliance
  - Energy efficiency
  - Structural soundness
  - Capacity as it relates to the enrollment and education programs
  - Expansion Options for the renovation and/or expansion of each building

#### b. Staffing Requirements

Certifications

- Efficiency from shared staff
- c. Budget Impact
  - Cost analysis
  - Building costs/useful life
  - Employee costs with new configuration

# **Potential Configurations**

- a. The District and the consultant should look at consolidating, if it is financially feasible, to either two school buildings or three school buildings.
- b. The District and the consultant should look at the proposal that consolidates four buildings to three school buildings housing Grades K-3, Grades 4-7, and Grades 8-12.
- c. The District and the consultant should look at a proposal that consolidates four school buildings to two school buildings housing Grades K-6 and Grades 7-12.

Nothing in this Resolution in intended to limit the District or the consultant. If necessary, modifications can be made to the Facility Master Plan if there is a more cost effective way to present necessary information to the Board of School Directors.

The District is directed to request proposals from qualified architectural firms to provide an analysis in the form of a Facility Master Plan.
