

**AGREEMENT BETWEEN WELLSBORO AREA SCHOOL DISTRICT  
AND SNYDER'S DRIVING SCHOOL, L.L.C.**

This Agreement is entered into this \_\_\_ day of \_\_\_\_\_, 2019, by and between WELLSBORO AREA SCHOOL DISTRICT and SNYDER'S DRIVING SCHOOL, L.L.C.

The purpose of the Wellsboro Area School District's ("WASD") affiliation with Snyder's Driving School, L.L.C. is to assist WASD students to obtain a Pennsylvania automobile operators license and promote safe driving habits within the requirements of the Pennsylvania Department of Transportation.

Snyder's Driving School, L.L.C. will provide and maintain all equipment (including automobiles), personnel, and materials for a Pennsylvania driver's training program.

Snyder's Driving School, L.L.C. has obtained any and all licensures, certifications, and teaching credentials required by the Commonwealth of Pennsylvania.

Snyder's Driving School, L.L.C. agrees to maintain a comprehensive liability insurance policy acceptable to the Wellsboro Area School District during the term of this Agreement, with a responsible insurance company, with a minimum single limit coverage of \$1,000,000.00 and shall furnish the School District with a certificate of such liability insurance, stating that the said insurance is in full force and effect during the term of this Agreement or any extension thereof.

The Contractor agrees that it will not discriminate on the basis of race, color, religion, sex, national origin, or disability in its program, and will comply with all requirements of the Civil Rights Act of 1964 and the Americans with Disabilities Act of 1990.

Snyder's Driving School, L.L.C. will maintain vehicle(s) that meet or exceed State Department of Education requirements for driver education vehicles.

This Agreement is for the 2019-2020 school year and must be renewed annually between the subject parties.

It is incumbent upon all instructors from Snyder's Driving School, L.L.C., who will be providing direct training with Wellsboro Area School District students to submit a criminal history background check and a Pennsylvania child abuse history clearance, and the requirement that the owner of the driving school have at least two years of successful driver education teaching experience.

Pursuant to Pennsylvania law, Snyder's Driving School, L.L.C. must maintain student records for a period of five years. Furthermore, Snyder's Driving School, L.L.C. may advertise that they are licensed by the Department of Education for instruction for the purpose of inducing and soliciting prospective students to enroll and use the services of Snyder's Driving School, L.L.C.

The parties understand that Snyder's Driving School, L.L.C. will bill the respective students independently, and the Wellsboro Area School District will not be responsible to compensate Snyder's Driving School, L.L.C. in any way, shape, or form.
