- 1. All staking layout and establishment of grades is to be done by others and clearly indicated. ATT accepts no responsibility for improper engineering and/or areas where no grades were clearly indicated before commencement of work.
- 2. The asphalt pavement that the new all weather polyurethane system is to be applied on must conform to all American Sports Builders Association Guidelines and national Federation of State High School Association Requirements. Any corrective work necessary to conform to these guidelines and requirements will be considered extra work and not part of our lump sum or unit price proposal
- 3. The asphalt surface is to be reasonably clean prior to ATT commencing the polyurethane surfacing. The asphalt surface must meet all slope, smoothness, and planarity and quality guidelines as established by the American Sports Builders Association.
- 4. Any completion date given is subject to change as a result of adverse weather conditions, site conditions/and or any condition, not controlled by ATT that might alter ATTs ability to perform its work. ATT will not be responsible for delays due to these conditions.
- 5. This proposal is based on current material, rental, and labor pricing as of the date of this proposal. If the project is delayed or our work under this proposal is pushed into the next calendar year, ATT will be entitled to a price increase matching any increased in Labor (PW rates as well as base rate) and increase in material costs as posted by approved system supplier.
- 6. Owner/Contractor must provide ATT with clear and reasonable access to site
- 7. This proposal is offered with the understanding that in the event a "Separate" Contract is offered to perform the work this "Proposal" and the Terms and Conditions hereto will be attached as "Exhibit A".
- 8. Any union labor required due to the general contractors contractual union agreements. Project Labor Agreements, or job specific apprenticeship requirements, will be provided by the general contractor at no cost to ATT.
- 9. This proposal is good for 60 days from estimated bid date.
- 10. Structural spray systems (Spurtan BS, Spurtan BSS) will result in cracks along the edge between track surface and track system.
- 11. Polyurethane materials may flow over existing outer edges of track runway, high jump apron and places where there is no drain or curb
- 12. All running track striping performed by ATT will conform to the American Sports Builder Association Class 5 certification. Any additional work beyond the ASBA Class 5 Certification is considered extra work. Please see extra work note.
- 13. ATT cannot be responsible for the failure of a pavement to support a normal workload in the performance of the proposed work. More specifically, if it is required of ATT to travel over an asphalt or concrete pavement with any supply truck to furnish specific work, ATT cannot be responsible for the failure of the pavement profile and sub grade to support the supply truck. ATT will not be responsible for any remedial work required to repair any damaged areas due to normal construction traffic.
- 14. Payment shall be made Net 30 days from invoice date. No retainage is to be held. A finance charge of 2% per month, compounded monthly, will be applied to all past due balances beginning on the date of invoice.
- 15. In the event ATT Sports, Inc. is hired to supply and install any type a spray applied track system (Spurtan® "re-Top", Spurtan® BS, Spurtan® BSS otherwise "encapsulated" system) ATT will notify the owner and General Contractor two days prior to commencement of spray operations in order to have all vehicles and/or mobile appenturances removed for a distance of 500′ from the nearest point of spray application to the track. Failure of Owner/General Contractor to remove or take precautions relieves ATT Sports, Inc of any liability should vehicles have spray damage.
- 16. In the event that a track surface is to be removed and replaced without any remediation to the asphalt base, ATT is to inspect the existing base and notify the owner/contractor of any price increases via change order.
