Service Agreement between Northern Tier Industry & Education Consortium (NTIEC) and Wellsboro Area School District

for Academic Years – 2023/2024 – 2024/2025

As a member district of the Northern Tier Industry & Education Consortium (NTIEC), we will provide services to Wellsboro Area School District at the rates summarized below for academic years 2023/2024 – 2024/2025.

Paid/Unpaid / School-to-Work (STW) Internship and Apprenticeship Programs

- First 8 Students – \$1,400.00 per student
- 9-15 Students – \$1,000.00 per additional student
- 15+ Students – \$700.00 per additional student

NTIEC resources serve as an agent of the school district to provide all services required to meet Pennsylvania youth program guidelines. This includes facilitating and maintaining all paperwork required from student and employer (including clearances where required), regularly monitoring student progress, facilitating and communicating evaluations and problem resolution. NTIEC can source an employer for a student applicant or they can work with a student's existing employer to complete the requirements to qualify an existing part-time job as an internship.

Interns are paid/unpaid part-time employees therefore they are covered by employer insurance policies and by federal/state employment regulations while they are working. Student participants are responsible for their own transportation to and from the work site.

Consent to Service Agreement

By signing this service agreement, the school district agrees to:

1. The NTIEC fee structure outlined in this agreement and to provide payment for services in accordance with this structure. Invoicing will be done three times per year (November, March and May).
2. Indemnify and hold harmless NTIEC, its employees, its board of directors and its partners in these programs from any and all losses, damages, claims and actions arising out of their sponsorship and participation in the listed activities except as such that may be due to negligent or unlawful acts.

Northern Tier School-to-Work Rate Schedule

The following rates will apply for the 2023/2024 and 2024/2025 academic years for career pathway services.

Work-Based Learning Services

School-to-Work Job Shadowing, Internships (Paid/Unpaid), and Apprenticeships

- First 8 students @ \$1,400.00 per student
- 9-15 students @ \$1,000.00 per student
- 15+ students @ \$700.00 per student

Rates listed above will be prorated based on individual student admission dates into a program.

Specialized Career Services

- Externships—5-8 weeks, unpaid opportunities (e.g., hospital, dental, veterinary, etc.) @ \$200.00 per student

Other Career Services

- Participation in career pathway presentations, lecture series (professionals in the classroom), one-on-one virtual conversations with a professional, mock interviews, work-site/academic tours, etc. @ \$2.50 per student enrollment in K-12 in the district.

Transportation

- Reimbursement will be considered on a case-by-case basis. Schools will need to submit a request in advance with the number of students and mode of transportation.
